

The 3 had lunch without incident and _____ went back to work. _____ returned about 5:30 pm and the three went to the park. After dinner, with all 3 residents in the living room, _____ told _____ that she needed to tell her something. _____ told _____ the following: While _____ was at work, Romeo came into her room with his "Coooca" (Penis) out of his pants asking _____ to touch it. _____ told him no and noted that there was "water coming out of it." Romeo then pulled _____ pants down and rubbed her vagina with his fingers underneath her underwear, without digitally penetrating her. _____ confronted Romeo and he stated, "You're going to believe a 5 year old kid over me?" _____ brought _____ outside, away from Romeo and confirmed her story several times. _____ advised that _____ knew that only _____ and the doctor were the only ones to touch her private areas. _____ stated that _____ didn't even know what male genitalia was and she referred to Romeo's penis as a "Coooca", which is what _____ called her vagina. _____ stated that Romeo's Coooca looked like a tube and that she told him that she didn't want to touch it. _____ also told _____ that when Romeo started to rub her



Cocca, she told him to stop and that it hurt. [REDACTED] immediately called police. Units responded, DCF was notified and Romeo was transported back to DBPD. Crime Scene responded as well and collected [REDACTED] shirt that she wore today, which may have been partially ejaculated on by Romeo during the incident.

Romeo only spoke Spanish and I utilized Ofc. Caceres for translation. Romeo was read his Miranda Warnings in Spanish, which he stated he understood and waived. In a taped statement Romeo initially stated that other than playing ball outside for a little while, the day was uneventful. Romeo stated that [REDACTED] mostly played with the I-Pad while he watched television and took a nap. Romeo denied anything out of the ordinary occurring and confirmed that [REDACTED] came home around 1:00 pm so the 3 could eat lunch together. After further questioning Romeo changed his story several times and said that while he was taking a nap, [REDACTED] walked into his room and attempted to pull his shorts off with her hands reaching into his shorts to grab his penis. Romeo said that he smacked her hands away and may have grazed her inner thigh. Romeo told us that her act did excite him a little bit sexually but was not something he would act on. Romeo also stated that he went into the bathroom to urinate with the door partially closed and [REDACTED] walked in telling Romeo, "Let me see it." Romeo claimed "seeing it" referred to wanting to see his penis. Romeo could not provide any logical explanation to a 5 year old child, living in a stable environment, acting like that. Romeo stated that he never [REDACTED] Romeo initially stated that he never went in [REDACTED] room the entire day but later changed his story that [REDACTED] "needed help" getting dressed as her shorts were too tight and she couldn't get them on. Romeo advised that for unknown reasons he helped pull her shorts up from the front and not the sides. As he pulled the shorts up he accidentally grazed her vagina area, which Romeo stated also excited him a little bit. [REDACTED] stated that she was going to tell [REDACTED] Romeo never called [REDACTED] at work to inform her of [REDACTED] alleged actions because he didn't feel it was a big deal.

Romeo finally stated that when he helped [REDACTED] get her shorts on he could see that she wasn't wearing any underwear. Romeo could see most of her vagina and he intentionally pulled the pants up slowly from the front so that his fingers would slide over the outside skin of her vagina. Romeo used his ring finger and pinky finger to intentionally rub [REDACTED] vagina as he pulled her pants up. Romeo stated he never inserted his fingers into the vagina. Romeo claimed that immediately after it happened he felt that he made a poor decision.

Based on the above listed facts, probable cause exists to charge Romeo Lopez-Lopez with Lewd & Lascivious molestation to a victim under 16 years of age, violation of FSS 800.04 (5) (b).
