	<p>On 5/14/2017 at approximately 2047 hours I was dispatched to [REDACTED] in reference to a domestic disturbance.</p> <p>Upon arrival I made contact with the complainant, [REDACTED] outside of their home. [REDACTED] advised that [REDACTED] Megan Philp was intoxicated and attempted to break down the master bedroom door to attack [REDACTED] who was hiding from Megan. [REDACTED] advised she was hiding in the master bedroom with the door locked because she was scared of Megan. [REDACTED] stated that Megan was punching the door so hard it caused a hole. [REDACTED] advised the argument began over Megan playing the stereo to loud. I could visibly see the hole Megan caused on the door by punching. I took photos and submitted into evidence.</p> <p>I then spoke to [REDACTED]. [REDACTED] advised upon seeing Megan, attempting to break down the bedroom door and attacking [REDACTED]; he grabbed Megan to move her out of the way. [REDACTED] stated he did this in order protect [REDACTED]. [REDACTED] advised that he tried to move Megan into her bedroom which is located directly across the hall from the master bedroom. [REDACTED] stated that Megan then grabbed him and anchored herself so she wouldn't move. [REDACTED] then stated he attempted to pick up the telephone to dial 911 and that's when Megan disconnected the phone from the wall to prevent him from dialing 911. [REDACTED] then advised right after Megan disconnected the phone from the wall he then ran out of Megan's room to get his cell phone and that's when he was tripped by Megan. [REDACTED] suffered a few cuts on his foot.</p> <p>I then made contact with Megan. Megan was visibly intoxicated and slurring her words. Megan advised that she was listening to music and was told to shut it off and this upset her, Megan stated she is an adult. Megan then advised that she went to the master bedroom and tried to get her makeup back from [REDACTED]. Megan advised she could not gain entry into the bedroom because the door was locked. Megan stated that [REDACTED] grabbed her and moved her into her bedroom and that's when she grabbed on to him.</p> <p>Based upon my investigation I arrested Megan Philp for F.S.S. 914.22- Tampering with and harassing [REDACTED] and [REDACTED], Megan knowingly intimidated and used force towards [REDACTED] by hindering/delaying and prevented the communication to law enforcement by disconnecting the phone when [REDACTED] tried to call 911 and F.S.S 784.011- Assault on [REDACTED], Megan intentionally and unlawfully threatened by act to do violence to [REDACTED] by punching the door and causing a hole. [REDACTED] locked herself in the master bedroom because she was put in a well founded fear that violence was imminent. F.S.S 784.03(1A)- Simple Battery - Megan actually and intentionally touched [REDACTED] causing him to trip and fall. Megan was transported to booking without incident and then to TOTCJ.</p> <p>I had [REDACTED] and [REDACTED] fill out a written witness statement. I provided [REDACTED] with a Domestic Violence pamphlet, which he signed for. I submitted the written witness statements into evidence.</p> <p>I submitted pictures of the door and the injuries [REDACTED] sustained into evidence.</p>
