On 01-24-18 a lawfully obtained search warrant was executed by PBSO Narcotics agents at 865 Carlee Circle, Boynton Beach Florida. This was following a long term investigation into the residents, Dale Horne and Aleksandra Zynis. Upon executing the search warrant Zynis and Horne were present in the home. I entered the home through the garage and into the laundry room, kitchen area. I was immediately able to detect the strong odor of fresh marijuana which I recognized through my training and experience. There were marijuana cigarettes with what appeared to be THC wax on the tips in plain view in the kitchen along with a ball of THC wax on a paper plate on the counter top. I located a cooler in the laundry room containing a two large vacuum sealed bags. Inside of the bag was what I recognized to be marijuana which weighed 1054.2g. This packaging is consistent with the sale and transportation of large amounts of marijuana. I located a vacuum sealer machine on the kitchen counter which utilizes the same type bags as found in the cooler. On the floor below the vacuum sealer I located a black Pelican case containing 18 plastic bags containing marijuana with an approximate total weight of 1678.4g. The following is a list of evidence located in the kitchen area. 8 plastic bags containing marijuana with approximate weight of 893.7g in kitchen island cabinet 2 vacuum sealed plastic bags containing 110.5g of marijuana "roaches" in kitchen drawer 2 ziploc bags containing marijuana (19.2g) found in mason jar in kitchen gold plastic container with marijuana approximate weight of 31g in kitchen 5 unused vaporizer tips containing 75% THC oil on kitchen counter 12 unused vaporizer tips containing 75% THC oil on top of refrigerator plastic bag containing 21.1g of Hash butter in freezer large plastic bags containing THC edibles in kitchen island cabinet Digital Scale and 3 unopened bottles of CBD oil In an office area of the residence there was what appeared to be a narcotics packaging station set up. There were miscellaneous small bags, foil tape along with the following evidence:

Black Pelican case containing 16 bags of marijuana (649.3g), vacuum sealed bag with marijuana wrapped in foil containing 2.6g of marijuana, 3 plastic bags of hash oil (30.2g) miscellaneous plastic bags consistent with narcotics packaging orange backpack containing 16,625g (36.65lbs) of THC edibles in office closet. These edibles are made to look like gummy candies and cookies.

A search of the master bedroom revealed 3 plastic bags containing 20.9g of marijuana and wax paper containing 9.8g of hash butter.

The following is a partial synopsis of the narcotics recovered from the residence:

Marijuana - 4,484.1g (9.88lbs)
 THC edibles (gummies, cookies) - 16,625g (36.6 lbs)
 Hash (butter, oil) - 62.6g
 THC filled Vaporizer tips containing 75% THC concentration - 285.6g
 3 bottles CBD Oil - 373g

A records check of 865 Carlee Circle, Boynton Beach through the Palm Beach County Property Appraiser revealed that Dale Horne is the property owner. Zynis and Horne are living at this address and their Florida Drivers Licenses list this as their residence.

On 03-05-18 I received the PBSO Crime Lab report on the orange and green gummy candies recovered during this search warrant. The results reveal DELTA-9-TETRAHYDROCANNABINOL Schedule I substance. These "candies" are very potent according to Horne who stated that "you can only eat one of them and then wait". "If you eat more than that you will be messed up for days". Horne made spontaneous utterances about the "candies"/edibles being "very potent". Horne stated that you can "only eat one and wait because if you eat more than that you will be messed up for days".

Based on this information I believe that there is Probable Cause to charge Dale Horne and Aleksandra Zynis with Trafficking in Synthetic Cannabinoids in violation of FSS 893.135(1)(M)(2)(C) and Own or rent property for trafficking, Sale and or Manufacture of Controlled Substance in violation of FSS 893.1351(1), Possession of Marijuana Excess 20g with Intent to Sell in violation of FSS 893.13(1)(a), and Possession of Schedule I Substance (Hashish) with Intent to Sell in violation of FSS 893.13(1)(a)
