On the 3rd day of June 20 18 at 21:00 A.M. P.M. (Specifically include facts constituting cause for arrest.)

I responded to the intersection of Palmetto Park Road and US Highway 441 (South State Road 7), in unincorporated Boca Raton, Palm Beach County, Florida for a crash that just occurred.

Upon arrival I made contact with Clovis Santana and Andrea De Santana who were respectively the driver and passenger of a Dodge Caravan bearing Florida tag 848THR. They explained that they were stopped on the Northbound lanes of US 441 at the traffic light of Palmetto Park Road, when a silver Mitsubishi that was coming from Eastbound Palmetto Park road turned Southbound on Northbound side of US 441, hit the front of the Dodge Caravan, then drove over the curb of the median to return on the Southbound lanes and continued Southbound.

Both occupants of the Dodge sustained injuries during the crash and were transported by Palm Beach Fire Rescue to West Boca Medical Center. Andrew Barash witnessed the crash and followed the Mitsubishi Southbound.

There, at the intersection with Sandalfoot blvd, the Mitsubishi that was again driving Southbound on the Northbound lanes of US 441 hit a red Toyota bearing Florida DSJC87 driven by Jorge Barco Bermudez and continued without stopping. Barco Bermudez followed the Mitsubishi that was bearing Florida tag DDPM15. He attempted to attract the attention of the driver without success.

D/S Collura (#26708) went to the TW bar parking lot at 23269 South State Road 7 where the Mitsubishi was last seen and found the vehicle. Next to it was standing a female, later identified by her driver's license as Melissa Mannarino. In a spontaneous utterance she said that she was the owner and driver of the vehicle. She then pointed at the damage on the front left of the Mitsubishi saying that it was an old damage and that she was a bad driver. I arrived a few minutes later. I approached Mannarino. I smelled a strong odor of unknown alcohol beverage coming from her breath. Her eyes were glassy and bloodshot. Mannarino told me again that she had been driving from home to the bar a few minutes earlier. She then explained that she had been drinking three cocktails at the bar. The bartender told us that she arrived a few minutes earlier and ordered one drink that was still full on the counter.

I observed the damage on the front of Mitsubishi that was matching the damage on the crash with the Dodge. Also one of the part found on the crash scene was matching a missing part on the Mitsubishi. Barco Bermudez came for a show up and confirmed that Melissa Mannarino was the driver of the vehicle that hit him.

committed the below acts in my presence. was observed by witnesses who told me that he/she saw the arrested person commit the below acts.

confessed to admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.

On the 3rd day of June 20 18 at 21:00 A.M. P.M. (Specifically include facts constituting cause for arrest.)

Based on my investigation, I had probable cause that Melissa Mannarino did drive a motor vehicle involved in a crash that occurred on public or private property which resulted in injury other than serious bodily injury to Clovis Santana and Andrea De Santana or any person and Melissa Mannarino did willfully fail to immediately stop the vehicle at the scene of the crash or as close thereto as possible, or did willfully fail to remain at the scene of the crash until he or she fulfilled the requirements of Florida Statute 316.062, contrary to Florida Statute 316.027(2)(a).

I had probable cause that Melissa Mannarino did drive a vehicle involved in a crash resulting only in damage to a vehicle or other property which was driven or attended by any person, and did fail to immediately stop such vehicle at the scene of such crash or as close thereto as possible and forthwith return to the scene and remain at the scene of the crash until he or she fulfilled the requirements of Florida Statute 316.062, contrary to Florida Statute 316.061(1).

I arrested Melissa Mannarino and drove her to West Boca Medical for a medical clearance. There, she became agitated, was constantly yelling and became such a nuisance for the other patients in the emergency room that she had to be transferred to a secluded room. There, at one point, she slipped her cuff out and ran through the emergency room attempting to escape from custody through the staff exit.

When put back in custody, she pulled away from D/S Collura and Sgt Johnson (#9193). The blood result showed that Mannarino blood alcohol was 0.191 g. THC and [redacted] were also present in the lab results. Once Mannarino was medically cleared, we walked her back to my car, where she again pulled away from us, resisting without violence.

Based on my observation I had probable cause that Melissa Mannarino did escape or attempt to escape while being transported to or from a place of confinement or did willfully fail to remain within the extended limits of her confinement, contrary to Florida Statutes 944.40, 945.091(4), and 951.24(4).

I also had probable cause that Melissa Mannarino did resist, obstruct or oppose D/S Collura, a law enforcement officer of the Palm Beach County Sheriff's Office, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02.

I also had probable cause that Melissa Mannarino did resist, obstruct or oppose Sgt Johnson, a law enforcement officer of the Palm Beach County Sheriff's Office, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02.
