NARRATIVE:

The undersigned has probable cause to believe the above-named defendant on 21 of December 2018 at 14:00 at NB INTERSTATE-95 (Zone: 1) in County did

While on Interstate patrol in Palm Beach County on December 21, 2018 around 2pm, while traveling northbound on Interstate-95 (State Road 9), I observed a red with black stripes, Ford Mustang, with Florida license tag of " CURS61 ", traveling northbound on Interstate-95 at a very high rate of speed, visually estimating a speed over one hundred miles per hour, weaving through traffic without signaling.

After getting through traffic, with myself in the left (# 1) lane, and the red Ford Mustang in the far right lane, I was able to catch up to the vehicle, and was parrel to it. I slowed down, and safely changed lanes to the right, coming to behind behind the Ford Mustang. I then activated my fully marked Florida Highway Patrol vehicle's emergency red and blue lights, and siren, to attempt to conduct a traffic stop due to it's very high rate of speed, while changing lanes through traffic without using it's turn signal.

The red Mustang failed to stopped upon the activation of my patrol's vehicle's emergency lights and siren. It kept traveling northbound. The vehicle still in the far right lane, began to exit onto the northbound Interstate-95 exit ramp to State Road 806 (Atlantic Ave). The unknown driver, possibility white female driver threw out an unknown white in color piece of paper, then reached out from the driver's side, and held an unknown black in color can. The driver then tossed the black in color can towards my direct, but the object did not strike my vehicle, by flying to the right of me.

Seeing this vehicle had no intention of stopping, and just ahead was stopped traffic at the traffic control lights for westbound, and eastbound State Road 806 (Atlantic Ave), not wanting to put any motorist in harms way, I then turned of my vehicle's emergency lights, and siren, and stopped on the right paved shoulder of the exit ramp. The red Ford Mustang then drove around stopped traffic using the right paved shoulder, and turned eastbound on State Road 806 (Atlantic Ave).

Upon a computer check of the Florida license tag, it showed the vehicle being owned by a Rachel Nicole Voskressensky, (FL DL # V-262-734-95-849-0) 9892 Robins Nest Rd Boca Raton, FL 33496, and a Janet T. Goldstein (FL DL # G-432-438-60-663-0) 9892 Robins Nest Rd Boca Raton, FL 33496.

Later the same day, I traveled to the registered address of the Ford Mustang (Florida tag " CURS61 "), 9892 Robins Nest Rd Boca Raton, FL 33496 about 9pm, and met with the second listed owner Ms. Janet T. Goldstein (FL DL # G-432-438-60-663-0), and advised her for the reason I came to the residence. Before I asked any questions, I read Miranda Warning from a

department issued card. Ms. Goldstein stated that she understood the Miranda Warning that was read to her. I asked Ms. Goldstein being one of the owners of the vehicle in question, does she ever drive the Ford Mustang. Ms. Goldstein stated that she does not drive the Ford Mustang, and that the only person that drives the vehicle is her daughter Ms. Rachel Nicole Voskressensky (FL DL # V-262-734-95-849-0). When I asked Ms. Goldstein does she know where her daughter was at the moment, she stated that Ms. Rachel N. Voskressensky was at a personal residence working as a medical personal assistant. Ms. Goldstein stated that Ms. Voskressensky has dealt with mental issues for a number of years that require medically prescribed medication that help her maintain a stable state of mind. Ms. Goldstein stated that Ms. Voskressensky has not been taking the prescribed medication causing her to become unstable.

The next day, December 22, 2018, around 12pm, I traveled back to the residence in an attempt to talk to Ms. Voskressensky. I rung the door bell, and Ms. Voskressenger came to the door, and stepped outside. She stated that she knew the reason why I was there. I then read Miranda Warning at 12:31pm to Ms. Voskressensky from a department issued card. She stated that she understood the Miranda Warning. I first asked Ms. Voskressensky is she was driving the red Ford Mustang yesterday. She stated that yes, she was driving the vehicle yesterday. I the asked if she was the driver of the Ford Mustang at the time I was attempting to stop the Mustang on northbound Interstate-95 (State Road 9). She stated that she was the driver of the vehicle at the time of the incident. When asked where she was coming from, she stated she was coming from the Deerfield Beach, FL area, going to dog pounds to give out dog treats to dogs in kennels. I asked why she did not stop when I attempted to stop her, to her only response was only a smile. I asked her does she understand her actions during the incident was very dangerous, and could of caused other motorist harm. Her response was " I am a good driver ".

I asked what was the black object she held outside her vehicle's driver side, and threw in the direction of my patrol vehicle. She stated the black object was an empty Monster energy drink can. She stated she wanted to show me that she had a Monster energy drink. When asked what was the plastic bag or piece of paper she threw out her vehicle, she stated it was an empty potato chip bag.

The attempted traffic stop, and incident, was recorded by my Florida Highway Patrol vehicle camera system.

Based on the video recording of the incident, and Ms. Voskressensky admitting after Miranda Warning, that she was the driver of the vehicle, and knew I was attempting to stop her during the time of the incident, I am requesting a arrest warrant for Ms. Voskressenger for fleeing and attempt to elude.

All occurred in Palm Beach County.
