On the 2 day of February, 2019 at 22:16 (Specifically include facts constituting cause for arrest.)

On 2/2/2019 at approximately 2212 hours, I was dispatched to the area of 51 SE 1st Ave, O'Brians, in reference to a disturbance. The caller, B/M Delroy Thompson, advised that there was a W/M causing a disturbance and threatening customers. Thompson advised that they want the W/M removed and trespassed.

Upon arrival, I made contact with Thompson who pointed to the W/M. I approached the W/M asked him for his identification and he refused. I then explained to the W/M, who was later identified as Joseph Barrelli, that if he refused to leave the property, that he would be trespassed and if he further refused then he would be placed under arrest. I again told Barrelli to leave and he refused. I explained to Barrelli that he was now being trespassed from the property and he needed to leave or he would get arrested. Barrelli explained that he was not leaving until I gave him a piece of paper telling him to leave. I told Barrelli that there is no piece of paper that we provide and gave him a verbal command to leave the property before getting arrested. It should be noted that throughout this encounter, Barrelli stayed sitting in the chair and stated that he was not going to leave and that we have to do what we have to do.

After giving Barrelli multiple verbal commands to leave the property and him continuing to refuse, I then placed Barrelli under arrest for trespass after warning under FSS 810.09. He was transported to BRPD for processing. It should be noted that while in the back of my marked unit, Barrelli stated that I better hope that my salary pays for plastic surgery because he remembers faces. Barrelli also stated that my whole family better be able to get plastic surgery for their faces. Barrelli was additionally charged with threatening a law enforcement officer under FSS 836.12(2). Barrelli was then TOT CJ.
