NARRATIVE:

I am part of a National Task Force known as the South Florida Internet Crimes Against Children (ICAC). This task force investigates internet crimes against children, child exploitation, and related cases.

On 03/25/2020, [REDACTED] was assigned to further investigate Cyber Tip reports #65673004 and 65673791 from the National Center of Missing and Exploited Children (NCMEC) concerning images of child pornography being forwarded from the Broward County Sheriff's Office South Florida Internet Crimes Against Children Task Force. The Cybertips were reported by Google (Gmail). Gmail is a free email service developed by Google. Users can access Gmail on the web and using third-party programs that synchronize email content through POP or IMAP protocols. Google reported to NCMEC that one image and one video depicting the sexual performance of minors were captured within the Google Photos and Google Gmail infrastructure for user sdmanas2@gmail.com.

Cybertips are investigative leads generated by NCMEC. NCMEC is a non-profit organization that provides services nationwide for families and professionals in the prevention of abducted, endangered, and sexually exploited children. Pursuant to its mission and its congressional authorization (42 USC 5773) NCMEC operates the CyberTipline and Child Victim Identification Programs to assist law enforcement in identifying victims of child pornography and child sexual exploitation. NCMEC works with law enforcement, Internet Service Providers, electronic payment service providers, and others to reduce the distribution of child sexual exploitation images and videos over the Internet. NCMEC forwards reports of child sexual exploitation to law enforcement for the purposes of investigation and disposition.

The Cybertip reports indicated that account holder **SD Manas** with email address sdmanas2@gmail.com uploaded the file(s).

On 03/25/2020, [REDACTED] reviewed the files uploaded by the suspect. Those files are as follows:

1. File name Google-CT-RPT-a436b948f023f4a108221971060ce631-158380419894136437934.jpg -- is an image file that depicts a white female lying on her back on top of a tropical bed spread. The female is wearing only wearing a t-shirt and is nude from the waist down. The female has her knees pulled back to her chest. The female's vagina and anus are exposed. There is no pubic hair on her genital area. The female appears to be approximately 2 to 4 years of age based on the size of her body, the appearance of her face being young and the fact that she does not have pubic hair. This image was uploaded on 03/10/2020 at 01:36:47 UTC utilizing IP address 2601:58c:c080:85e0:88fa:47e1:8be5:a796. Google advised they reviewed the file.
2. The second file that was uploaded was also reviewed by [REDACTED] File name Google-CT-RPT-ac2feb0a6be27708cf02264a4d1778a8 is an anime video that is approximately 3 seconds in length. The video shows one young female sitting on an object nude, there are two other young females on either side of her. The female on top of the object has her legs spread and a male anime character inserts his penis into her vagina as the other females watch. Again, true age can't be determined because this is an anime video but they do appear young. The file was reviewed by the electronic service provider. This image was uploaded on 10/18/2019 at 18:49:38 UTC utilizing IP address 73.125.28.22. Google advised they reviewed the file.¹

According to the American Registry for Internet Numbers, the provider of the IP addresses that the suspect utilized to upload the images is Comcast Internet Services. On 03/26/2020, [REDACTED] served a subpoena to

██████████ determined the provider for the suspect's phone number 561-901-8228 was Cingular Wireless which now belongs to AT&T. On 03/26/2020, ██████████ served a subpoena to AT&T to obtain basic subscriber information for the suspect phone number 561-901-8228.

On 03/27/2020, ██████████ received subpoena results from Comcast Internet Services for both IP addresses. The subpoena results revealed the subscriber of the suspect IP addresses to be:

On 04/07/2020, ██████████ received subpoena results from AT&T that indicated the subscriber of the suspect's phone number 561-901-8228 to be **David Manas** with user address, **23152 SW 58th Avenue Boca Raton, FL 33428**. The AT&T account has been active since 1/21/2011.

On 06/25/2020, this case was turned over to Your Affiant. I reviewed the cybertips, the uploaded files, and all of the subpoenaed records obtained by ██████████ and verified all of the above referenced information.

On 06/30/2020, I served a search warrant on Google for any and all data contained within the account for sdmanas2@gmail.com.

On 07/28/2020, I received records from Google in response to the search warrant. Items of importance found in that documentation include the following:

- a. In the Google Photos file for the account I found anime video Google-CT-RPT-ac2feb0a6be27708cf02264a4d1778a8 documented above.
- b. In the Gmail account I found image Google-CT-RPT-a436b948f023f4a108221971060ce631-158380419894136437934.jpg documented above.
- c. A BB&T Bank statement in the names of David S. Manas and Barbara Manas with an address of 23152 SW 58th Avenue, Boca Raton, FL 33428.
- d. A PDF file titled "Barbara-last two paystubs" which shows receipts for payment to Manas Family Daycare with address 23152 SW 58th Avenue, Boca Raton, FL 33428.
- e. Mr. Cooper mortgage statement in the name of David Manas with the same address in Boca Raton.

On 07/29/2020, the Honorable Judge Mark Eissey approved a search warrant for David Manas' residence.

On 07/30/2020, members of the PBSO TAC Unit and Computer Crimes Unit met at 0600 hours to be briefed and review the pending execution of the search warrant. PBSO TAC Unit executed the search warrant shortly after.

On 07/30/2020, PBSO [REDACTED] and I made contact with Manas outside of 23152 SW 58th Avenue in Boca Raton. Manas was escorted to my unmarked PBSO issued vehicle for privacy reasons. I read Manas his rights from a pre-printed Miranda Rights card, which he indicated he understood and signed indicating same. I informed Manas that Google reported that images depicting the sexual performance of a child were discovered in his Google email communications and Google Drive. Post Miranda, Manas stated that he does watch pornography and said that sometimes when he's online child pornography will pop up. Manas defined a child as being under 14 years of age. Manas initially stated that we wouldn't find any child pornography on his digital devices, but when questioned further he asked for an attorney.

[REDACTED] conducted an on-scene preview of Manas' iPhone and his Asus tablet. [REDACTED] advised that on the tablet alone he found in excess of 30 images depicting child sexual exploitation.

Based on my investigation, the suspect did knowingly possess 30 or more images of sexual performance by a child in violation of Florida State Statute 827.071(5).
