Officers of the Boynton Beach Police Department responded to the area of 1 Velaire Drive, Boynton Beach, Florida in reference to a report of an explosion which occurred on Hoadley Road just south of the intersection of Old Boynton Road (Boynton Beach Florida).


As officers arrived on scene they located what appeared to be a detonated device in the roadway. They also located several devices which appeared to be PVC pipe bombs along the roadway. Officers backed out of the area, cordoned off the block, and contacted the Palm Beach County Sheriff's Office (PBSO) Bomb Squad who responded to the scene. While waiting for PBSO to arrive on scene officers were approached by a citizen who mentioned there is a resident of 1250 Old Boynton Road, known only as "Greg" who makes his own explosives and sets them off periodically. No further information was immediately available about the potential suspect.

PBSO located six suspected destructive devices which each consisted of a PVC pipe which was sealed with a PVC cap on each end and had a fuse attached. Each suspected device was rendered safe and opened on scene where it contained black powder explosive material. Several devices also had metal screws placed in the PVC, as well as assorted nails and metal pellets mixed in the explosive powder. There was also debris scattered around the area from detonated devices and several partially detonated devices found.

While securing the area for BBPD crime scene and PBSO Bomb Technicians I located a brown cardboard box that was sitting on top of an opened dumpster which was placed along the side of the road just west of 1250 Old Boynton Road. It should be noted the aforementioned building is an apartment complex which contains approximately 12 units. The box was partially open and I could clearly see black plastic bottles and prescription medication type bottles protruding from the opening. The box was addressed to (suspect) GREGORY HAASZE with a address of 1250 Old Boynton Road Apartment 305, Boynton Beach Florida, 33426.

BBPD crime scene checked the box and the contents of the dumpster and located several bottles of black gunpowder, and several additional destructive devices. Officers formed a perimeter around apartment 305 to secure it based on the information gleaned from the package in the dumpster. While officers were standing in front of the apartment, HAASZE exited the residence and turned himself over to patrol officers. As HAASZE approached the officers he spontaneously uttered he was the reason why law enforcement was there and the stuff in the dumpster was his.

HAASZE was taken into custody and arrested based on the aforementioned circumstances. HAASZE was transported to BBPD. While at BBPD a recorded interview was conducted with HAASZE. HAASZE was given Miranda warnings and agreed to provide a sworn statement. During the subsequent interview HAASZE stated he has made "devices" for several years. He recently made several devices for the Independence Day holiday. HAASZE procures the materials to make the devices through the website "EBay" using his Android cellular phone. HAASZE fully admitted the devices were intended to detonate however he maintained he never intended to harm anyone. HAASZE admitted to placing pellets in and around the devices which he claimed he used to remove tree stumps. HAASZE did not provided a coherent reason why several detonated devices had pellets in/on them except to say he may have mixed them up with other devices on the Fourth of July. HAASZE did not attempt to remove any tree stumps from around his residence recently. HAASZE also claimed to have detonated approximately three devices between August 9, 2020 and August 12, 2020. When asked how the explosive materials came to be in the dumpster, HAASZE stated he saw the police activity around his home and realized he was in trouble. He decided to empty his home of the explosive materials and placed all of them in the dumpster. HAASZE claimed to have dumped black powder, magnesium, and several undetonated devices in the dumpster.

During the interview PBSD continued to canvas for additional explosive devices. In total, 26 explosive devices were found in the dumpster and the area immediately surrounding HAASZE's residence. The suspected explosive material from one of the explosive devices was subjected to a flammability test with a positive result indicting reactive (black) powder. The test was conducted using an XD-2i colorimetric test with reagent 2.

Based on the aforementioned circumstances HAASZE was charged with 26 counts of Making, Possessing, Throwing, Projecting, Placing, or Discharging a Destructive Device pursuant to Florida Statute 790.161 (1). He was processed at BBPD and TOT PBCJ.
