NARRATIVE:

D/S Reardon # 18654 responded to the Alamo rental car located at 2121 Belvedere Road, unincorporated West Palm Beach, Palm Beach County, Florida 33409 in reference to an overdue rental.

Upon her arrival at the business, she made contact with the manager at the Alamo/Enterprise/National Car Rental, Leslie Thornhill. Ms. Thornhill stated she needed to report the 2020 gray Nissan Maxima bearing Florida tag JALF80 as a failure to return.

Ms. Thornhill indicated that the vehicle was due back on 05/10/2020 and was rented by a Lynne Larson on 04/10/2020. Ms. Thornhill signed the stolen vehicle affidavit and provided D/S Reardon with the necessary paperwork including the certified demand letter and the registration for the vehicle. This paperwork was later placed into evidence.

D/S Reardon entered the vehicle in as a Failure to redeliver hired vehicle/ stolen vehicle. The case was then forwarded to the Auto Theft Unit.

On 6/10/20 I met with Ms. Larson and I informed her of the investigation into her failing to return the rental vehicle. Ms. Larson stated " I'm glad you're here it is a long story". Ms. Larson then provided a sworn statement in which she admitted that she is the original renter of the vehicle and that during that time she relapsed on crack cocaine. Ms. Larson stated that she sublet the vehicle to 'Chico', her crack dealer for crack

cocaine. Ms. Larson let him have the rental car until it was due back. Ms. Larson began to text Chico about returning the vehicle and Chico responded that he had already taken it back to the rental company.

Ms. Larson stated that she subsequently received the demand letter from Alamo Car Rental (EAN Holdings) and she realized that the car was never returned. Ms. Larson stated that she attempted to get a hold of Chico but the number was no longer connected.

I asked Ms. Larson why she did not report this to Law Enforcement and she stated that she thought she would get in trouble about the drug purchase and use. I asked her if she had any information that would help me identify Chico and she stated none other than he frequents Paul's Motel in suburban Lake Worth.

I asked Ms. Larson if she would prosecute against Chico for not returning the vehicle to her in a timely fashion so that she could return it back to the rental company on the original due date and she was very hesitant, did not appear as she wanted to but ultimately stated yes.

On 6/15/20 I obtained the copy of the rental agreement from evidence and the document revealed that the renter was Lynne Larson with a date of birth of 4/17/1958 and an address of 20 Colonial Club Drive, Apt #202, Boynton Beach, Florida.

The rental period was for one month commencing on 4/10/20 and ending on 5/10/20 for an unknown sum.

Also with the contract was the standard 'Demand Letter' dated 5/18/20, addressed to Ms. Larson at 20 Colonial Club Drive, Apt #202, Boynton Beach, Florida. This letter was sent via FedEx Priority overnight with a tracking number of 770490149502.



I conducted a search of the FedEx website and utilized their tracking site and upon inputting the listed tracking numbers it confirmed delivery to Ms. Larson address on 5/19/20 at 9:49 AM. The document was noted as "signature not required".

On 6/15/20 I was informed by the Palm Beach County Sheriff's Office Teletype Division that the 2020 Nissan Maxima bearing Florida tag JALF80 was recovered on 6/11/20, abandoned at 320 S CONGRESS PARK DR, Lake Worth Florida.

I have made numerous attempts to identify 'Chico' and it has met with negative results. The alleged phone number (561-577-6309) that Chico was using is registered to Evelyn Davis who resides at 2813 Nw 2nd St Pompano Beach FL.

On 6/16/20 I called the phone number in question and a male with a Spanish accent answered the phone. I identified myself to this male and my reason for contacting him. The male refused to confirm his identity and denied that he even knew Ms. Larson or that he had possessed the rental car.
