On the 11 day of SEPTEMBER 2020 at 1700  A.M.  P.M. (Specifically include facts constituting cause for arrest.)

On September 11, 2020 at approximately 0900 I was assigned to review PBSO case number 20-105707 which stated the following; On September 10, 2020, at approximately 1530 hours, deputies responded to the area of 6300-G La Costa Drive, Addison Pointe in unincorporated Boca Raton, in regards to a possible mental health crisis. The complainant, Dyanne Davies, stated she received an email from Elvis Yacub who stated he wanted to end his life by "suicide by cop." Davies stated she believed Yacub owns a rifle and a handgun.

Upon their arrival, deputies made contact with Davies who informed me she has known Yacub for approximately eight (8) years. Davies stated Yacub has struggled with alcohol and emailed her on September 9, 2020 stating he wanted to end his life. Yacub told Davies to contact Law Enforcement and state there was an active shooter at his address. Davies stated her concern increased when she received a video from Yacub in which he had a black semi-automatic handgun, places a loaded magazine into the weapon, chambers a round and points it towards the video camera recording the incident. By the placement, it appears Yacub was pointing the weapon at himself. After receiving the video, Davies called 911. Davies stated she did not believe anyone was residing at the residence with Yacub. After viewing the video provided by Davies, deputies did not see other people inside the residence. Deputies also made contact with the leasing office who confirmed that Yacub residing at the above location alone.

Deputies then contacted Yacub via telephone with the number provided by Davies. When Yacub answered the phone, he sounded to be under the influence of a substance as he was slurring his words. Yacub stated he did not want help and hung up. Deputies, attempted to contact Yacub several more times which met with negative results. While deputies were attempting to make contact with Yacub, Davies received another email from Yacub stating the police were coming and he was going to die.

Deputies were also contacted by Jean Agenor who stated he was concerned for Yacub as he also received the same video from Yacub with him loading a firearm that Davies had. Agenor stated he had known Yacub for approximately 10 years. Agenor further stated he received a phone call from Yacub at approximately 1230hrs on 09/10/2020. In the phone call, Yacub stated he was distraught and wanted to end his life. Agenor stated he called Yacub after receiving the video and during the phone call Yacub got angry and began accusing Agenor of contacting the police.

After reviewing the report, I contacted Davies who reconfirmed her association with Yacub over the last 10 years and her statements from September 10, 2020. Davies stated that Yacub is usually a good guy but has occasionally spoken about killing himself because he feels he has nothing here. Davies stated that she told Yacub to seek professional help but he is too scared to go to see a doctor. Davies informed me she began to receive several messages on September 10, 2020 in which Yacub was talking about killing himself and how much he loved her. Yacub then sent a video of him loading a semi auto handgun and pointing it at himself through the camera. Yacub was then seen putting the gun down and then hits it as if he was frustrated he was unable to commit suicide. Yacub then told Davies, via email, to call law enforcement and say there was an active shooter at his address so that he can have a shootout with law enforcement and die by suicide by cop.



[ ] confessed to [ ] admitting to the below facts. [ ] was found to have committed the below acts, resulting from my (described) investigation. On the 11 day of SEPTEMBER 2020 at 1700 [ ] A.M. [X] P.M. (Specifically include facts constituting cause for arrest.)

PROBABLE CAUSE STATEMENT

I then met with Agenor. Agenor, a pastor, who stated he has known Yacub for over 10 years. Agenor stated that on September 10, 2020 he began to receive the same type of messages and phone calls from Yacub that Davies had to include the video. Agenor stated that Yacub got mad when law enforcement showed up to his house and began calling and texting him blaming Agenor for contacting Law Enforcement. Yacub began threatening Agenor over the phone, and through text messages and emails. In the emails, Yacub stated that he was going to kill Agenor multiple times. Yacub also stated that he was going to kill Agenor's mother, wife and 8 month old child in front of him before he finally killed Agenor. Yacub also stated that he was going to go to Agenor's church on Sunday, September 13, 2020, and kill him there. Agenor expressed his fear and concern with the threats and believed that he and his family were in danger. Agenor then woke up to another email from Yacub stating that he wanted to kill him. Agenor provided me with copies of the text messages he received on September 10, 2020 from Yacub which contained the following: "cock sucker I'm coming for you" "you're next" "I'm coming after you" "you will die bitch I'm coming" "you're dead tell the cops" "I'm coming to your church, you're dead" "I'm going to kill you Germil" "I'm going to rip you apart Germil" "I'm gonna take away everything you love starting with your mother" "I'm going to kill your wife, kids, and everything you love" "I'm going to take your kids, your wife, and your mother" "Germil I'm coming after you you're dead" "The day I see you is the day I'll kill and murder you and your family" "I will find you and take everything you love right before your eyes" "I will find you Germil and kill you and rape all you love"

ADMINISTRATIVE

Agenor also provided me with a voicemail (September 10, 2020) from Yacub in which Yacub stated "you're going to die." Agenor also received an email from Yacub on 9/11/20 at approximately 0528hrs through his church account which only contained the subject "you're fucking dead bitch." The email contained no other message except the subject line. It should be known that both Agenor and Davies have spoken to Yacub in person, on the phone, and through email multiple times over the years and were able to identify Yacub's voice in the phone calls and confirm Yacub's phone number (561-305-4596) in the text messages and confirm Yacub's email address, (elvis.yacub@gmail.com). Davies further stated she was very familiar with the inside of Yacub's home and stated she was able to say with 100% certainty that the video was taken inside of Yacub's home. Based on my observations, investigation, and statements from Davies and Agenor, there is probable cause to believe that Yacub violated F.S.S. 836.10/Written Threats to Kill four times as he wrote or composed and sent electronic communication, whether communication be signed or anonymous, to Agenor, containing a threat to kill or to do bodily injury to Agenor and also threatened to kill or do bodily injury to members of Agenor's family (Agenor's mother, wife, and 8 month old child).
