	<p>On Thursday, 12/10/20, I was advised by Cpt Waites (School Police) of a photo that had surfaced on the social media platform, "WhatsApp" sometime on Wednesday, 12/09/20. Within the photo, an unknown male had in his possession an unknown make/model black rifle. The rifle was in a downward position, slung across his upper body. The male was holding the buttstock of the rifle with his right arm. Additionally, the male was wearing a School District of Palm Beach County polo shirt and appeared to be standing in what looked like a school campus; a ladder and metal coverings on the frame of the wall were seen in the background. When further information was retrieved, it was found that the male was a School District of Palm Beach County Employee and worked as a custodian at J.C. Mitchell Elementary (2470 NW 5th Ave., Boca Raton, FL). Upon arrival at J.C. Mitchell, the male in the photo was identified as Hoover Mora, custodian on staff. His identification was confirmed by Det. Supervisor Kaspro (School Police) and an anonymous individual (prefers to remain unnamed) who works at J.C. Mitchell. Mora was not on campus upon my arrival; Mora was believed to be home as he is normally scheduled for the night shift.</p> <p>Det. Supervisor Lockhart (School Police) made contact at Mora's residence, 6500 NW 2nd Avenue Apt 309, Boca Raton, FL. Post Miranda, Lockhart advised Mora confirmed that on Wednesday, 12/09/20, he took the photo with the rifle while on campus at J.C. Mitchell. Mora stated that though he took the photo with the rifle on campus, the rifle was not his. Mora provided that the rifle belonged to Domingo Urena Reinoso a colleague and custodian at J.C. Mitchell.</p> <p>I made contact with Urena Reinoso at J.C. Mitchell as he was on campus. Post Miranda, Urena Reinoso confirmed that Wednesday 12/09/20 after he clocked out (at approximately 1800 hours), he went home, grabbed his Smith and Wesson M & P AR15 rifle (black in color) and came back to J.C. Mitchell to show his colleagues, other custodian staff. Urena Reinoso stated he specifically waited for no students to be on campus. He stated he didn't know that it was wrong to have it on campus and he only intended to show the</p>
