[REDACTED] is a [REDACTED] and was working a private event there in a children's area. [REDACTED] observed a group of people near the check-in table of the private event who were trying to enter the area, but were unauthorized to do so. The group began to get loud and cause a scene, and refused to follow [REDACTED] instructions to leave. [REDACTED] stated an adult male, later positively identified by his CA D/L as Sean R. Stewart (w/m DOB: 09/01/80), got "about nose to nose" distance from [REDACTED] face. [REDACTED] stated [REDACTED] put the back of [REDACTED] right hand on S. Stewart's chest and informed him he needed to back up and create some space. S. Stewart then shoved [REDACTED] backward. [REDACTED] said another adult male, later positively identified by CA D/L as Roderick D. Stewart (w/m DOB: 01/10/45), then stepped toward [REDACTED] and threw a punch, striking [REDACTED] in [REDACTED] left ribcage area.

I made contact with Roderick Stewart, who stated he and his family approached the check-in table and attempted to have the children in their group gain access. R. Stewart stated that after being denied access, [REDACTED] became argumentative with his family, which in turn caused them to become agitated. R. Stewart apologized for his behavior in the incident.

I spoke with witness Olivia N. Pace (w/f DOB: 05/18/01) and Kaylyn R. Viteri (w/f DOB: 02/05/97) who are both employed by [REDACTED] and were also working the private event. They both stated they saw S. Stewart push [REDACTED] and then saw R. Stewart punch [REDACTED] in the chest. They both completed and signed Sworn Witness Statements.

I reviewed video footage taken from video cameras located at [REDACTED] which depicted the altercation. The captured video revealed both S. Stewart and R. Stewart as the primary aggressors. The group was standing in close proximity to each other when S. Stewart forcefully pushed [REDACTED] backward a few feet. As [REDACTED] regained [REDACTED] footing and stepped back toward S. Stewart, R. Stewart stepped forward and struck [REDACTED] chest with

Roderick Stewart was issued a Notice to Appear at the Palm Beach County Criminal Justice Complex, with a court date of February 5th, 2020.
