On the **4** day of **February**, **2021** at **00:04** (Specifically include facts constituting cause for arrest.)

This incident was captured on MVR.

On 02/03/2021 at approximately 1150 hours, I was on a follow-up for possible underage drinking at 395 NE Spanish River Blvd (The Whistle Stop). Ofc. J. Casas and Ofc. De La Rua were also on scene.

While standing outside of the establishment, I observed W/M Luke Jorris (04/23/02, 18 y/o) (who is known to Ofc. J. Casas) (Case # 2021-001214), consuming a what I know to be a Corona Extra (due to the labeling on the glass bottle). Contact was made with Jorris, who was standing at the bar within the establishment. Ofc. J. Casas grabbed the back of Jorris's left tricep and directed him outside. Once outside, Jorris asked why he needed to go outside, which I replied, "underage drinking". Jorris looked around and attempted to run South through the parking lot. After a short pursuit, Jorris stopped and was immediately placed in handcuffs (which were checked for tightness and double-locked). Jorris identity was confirmed by his TX DL (ID # 42265438).

Jorris was placed under arrest for being in possession of alcohol under 21 y/o (F.S.S. 562.111) and resisting without violence (F.S.S. 843.02).

Ofc. J. Casas discovered that Jorris was in possession of a fake Texas Driver's License (located search incident to arrest inside his wallet) which displayed a birthday of 04/23/1997 instead of his actual birthday of 04/23/2002. He is additionally being charged with Possession of a Fake Driver's License per F.S.S. 322.212(1c). The fake Driver's License was submitted to BRPD evidence.
