On the 15 day of March, 2021 at 23:48 (Specifically include facts constituting cause for arrest.)

On 3/15/21 at approximately 1813 hours, I responded to 280 NW 20th St. to assist Fahren Parker with questions he had regarding how to register as a sex offender in the state of Florida. While I was speaking with Parker, I had BRPD dispatch check to see if he had any warrants. It was learned that Parker had an active warrant out of Arkansas for violation of parole. I identified Parker as being the subject with the warrant by matching his name, date of birth, social security number and Arkansas ID card which he provided me on scene.

Parker was placed in handcuffs behind his back (double locked and checked for tightness) and placed in the rear right passenger compartment of the BRPD transport van. After receiving the hit confirmation paperwork from BRPD dispatch, Parker was transported and turned over to PBCJ.

During a follow-up investigation it was learned that Parker is a registered sex offender out of the state of Texas.

At approximately 2348 hours, I met with George Diciurcio in the parking lot of 801 W. Yamato Rd. to follow up on the above case (BRPD case 21-3178). Diciurcio is the facilities director at 280 NW 20th St. and he provided a taped sworn statement (sworn in using a department issued "MVR recorded statements" card) advising that the defendant, Fahren Parker, had been living at the address since 3/9/2021. Diciurcio explained that Parker was aware that he needed to register as a sex offender, but he hadn't made any attempts to do so until today.

Based on Diciurcio's sworn statement I found that Fahren Parker was in direct violation of F.S.S. 943.0435(4a) after he failed to register as a sex offender within 48 hours after a change in any permanent, temporary, or transient residence.
