NARRATIVE:

I conducted a traffic stop on a '14, black, 4dr Honda, bearing tag # HBNY21/FL with Vin# on I-95 (N/B) Interstate just north of the 10th Ave N Overpass, in the City of Lake Worth Beach, FL 33460. I stopped the vehicle after witnessing a violation of FSS. 316.123(2)(a); Failure to Stop at a Stop Sign. This violation occurred at 9th Ave S/S F St, in the City of Lake Worth Beach, FL 33460.

The driver, later identified as, Zaker C. Hussein (11/2/02), did not immediately complied and finally stopped at the mentioned location. It should be noted I was in my assigned PBSO unmarked vehicle.

On reaching the driver's door I met with Hussein and after identifying myself, I explained the reason for the stop. Additionally, I made him aware that the vehicle window's tint might be too dark. I asked him for his driver's license and he told me he did not have one. I asked him if he owned the vehicle and he told me no that it belongs to his girlfriend. I then asked him for the vehicle's registration and he complied.

As I was talking to him, based on my training and experience, I could smelled the distinctive odor of burned Marijuana emanating from the vehicle. I asked him if he had a medical license for Marijuana and he told me no.

I ran his name/dob through NCIC/FCIC and FL DHSMV and it was confirmed [REDACTED]

I asked Hussein to step out and detained him. Once Agt. [REDACTED] arrived as my back-up, I turned custody of Hussein and turned my attention to the vehicle.

Based on the smell of the Marijuana I searched the vehicle and discovered the following:

1. An unzipped white backpack with "money" prints resting on the front, passenger's floorboard.
 - a. I searched the bag and found a sandwich size ziplock bag with two, round, blue tablets with the inscriptions: "A" on one side and on the other "76", in the main compartment. These were identified as Adderall 10mg ea.
 - b. Hussein's Identification card in an inside pocket, as well as, several other documents with his name [REDACTED].
 - c. Two containers with suspected Marijuana.
 - d. (3) Assorted brands of cigarette papers.

e. Brass knuckles.

I lifted the backpack to search underneath the seat and found on the floorboard a loaded black/gray Taurus .40 Caliber semi-automatic handgun. Model 740 Slim and serial # SLM05921.

I ran the handgun's serial number through NCIC/FCIC and [REDACTED]

I returned to Hussein and read him his rights from a PBSO pre-typed card. After he told me he understood them, he waived them and he told me the following:



1. The mentioned backpack belong to him.
2. The suspected Marijuana belong to him.
3. The two Adderall tablets where his because these are prescribed to him, to treat his ADHD condition. However, he couldn't provide me with proof.
4. The handgun belongs to a friend who was in the car yesterday. However, Hussein was aware there was a handgun in the vehicle.
5. The brass knuckles belongs to him.

Based on the above facts, I believe probable cause exists to charge Zaker C. Hussein with the following violations:

1. FSS. 790.23(1)(b); Possession of a Firearm (Delinquent Juvenile).
2. FSS. 790.01(2); Carrying a Concealed Firearm.
3. FSS. 790.01(1); Carrying a Concealed Weapon.
4. FSS. 893.13(6)(a); Possession of Adderall w/o Prescription.

Additionally, I issued to him a citation for violation of FSS. 322.03(1); No Valid Florida D/L.

I arrested Hussein and after checking the handcuffs for tightness, I double locked them. He was transported to the county jail.
