**NARRATIVE:**

On the above date and time, deputies responded to the Paul's Motel located at 5445 Lake Worth Rd., Greenacres, FL, 33463 in reference to a shooting. Prior to their arrival, PBSO's Communications Division received a 911 call from a female later identified as Jessica M. Montanez (W/F, DOB 06/25/1986), who said that she had just shot a male at this location. Upon deputies' arrival with Greenacres Fire Rescue Station #94, the male, identified via FCIC/NCIC as [REDACTED]

[REDACTED] was pronounced deceased at 17:10 hours.

At the time of deputies' arrival, Montanez was still on scene, along with her boyfriend, [REDACTED]. Both were transported to PBSO's District 16 Substation for interviews.

In viewing CCTV footage which faced the parking lot of the motel, I was able to see that at approximately 16:52 hours, Baca was seen approaching a blue vehicle which Montanez and Pietri had arrived in shortly prior. Montanez could be seen approaching Baca from the passenger's side, and hitting him as he backed up, with [REDACTED] approaching from the driver's side. All three continued to argue in the middle of the parking lot, and Baca then began retreating toward the motel. As he retreated, a gun could be seen in Montanez's right hand, who remained in the middle of the parking lot. [REDACTED] could then be seen approaching Baca, who had retreated to the area of a sidewalk on the far west side of the parking lot. [REDACTED] walked eastbound toward Montanez in the middle of the parking lot, but Montanez then stormed toward Baca, who was still on the far west side of the parking lot. As Baca stood in the same location, Montanez approached approximately 5-10 feet from him, and [REDACTED] walked up and stood by her side. Montanez could then be seen lifting the firearm with her right



hand, shooting, and then immediately walked back toward the vehicle. Within seconds of being shot, Baca collapsed in the same general location in which he had been standing previously.

In speaking with Montanez, she said that Baca and [REDACTED] had been arguing, and that after grabbing her previously, she retrieved her firearm when Baca rushed toward her. She denied holding the firearm in her hand prior to Baca approaching her a second time. Montanez said that she did not know what the argument was about, but said that she heard Baca say that he was going to shoot at her vehicle. She said that she did not see a weapon in Baca's hand during this incident. Montanez said that after shooting Baca, she placed her firearm inside her vehicle and called 9-1-1.

In speaking with [REDACTED] he said that he's known Baca for several years, but that he hadn't spoken to him since an altercation between them which took place ten years prior. He said that when they arrived at the motel, Baca approached him and told him to leave the property, which started an argument between the two males. He said that Montanez approached them in an effort to maneuver herself between the males. He said that Baca noticed that she had a gun in her hand, and became angry about that. [REDACTED] said that when Montanez shot Baca, Baca was "being loud", and was not flexing his muscles or actively approaching her. [REDACTED] indicated that Montanez interjected herself because she's "very protective", and added that he didn't "know what she was thinking."

Video surveillance from the Motel was consistent with the CCTV footage viewed upon arrival, which showed that Montanez approached Baca, and shot him as he stood across the parking lot from where their vehicle was parked.

As such, probable cause exists to charge defendant Jessica M. Montanez (W/F, DOB 06/25/1986) with First Degree Murder with A Firearm.
