At 1106 hours on 05/22/2023, I responded to 8081 Congress Avenue, Boca Raton for a Domestic Disturbance. An anonymous caller indicated that a male was standing in front of a Cadillac, not allowing the female driver to leave, while a young child was running around the vehicle.

Upon arrival I observed a black male standing in front of a 2017 Cadillac bearing Florida tag #BL40BH, which was across the sidewalk at the gas station exit. A young child was outside the vehicle. I took a position behind the vehicle, while officer Fowler took a position on the roadway, perpendicular to the vehicle. As we approached the male entered the rear driver's side door, and closed same. I opened the door and observed the child inside the vehicle, along with two other children. I requested the male passenger's name, who refused. I then made contact with the female driver. I requested her driver's license. The female driver promptly refused, stating that she did not have to provide the license because she was parked. The female further stated that she was pregnant, and did not have to provided her license. I instructed the female driver that if she did not produce a driver's license, she would be subject to arrest. The female driver turned her cell phone video camera on me, and repeated that she did not have to produce her license and that she was pregnant. I instructed the female driver numerous times that she would be arrested if she did not comply. The female driver still refused. I then took the female driver's left hand and removed her from the vehicle, while bringing her left hand behind her back and applied the handcuff. The female driver dropped to her knees upon exiting the vehicle. I allowed the female driver to slowly continue to the ground through her own power. I then brought her right hand to her back, securing same in the handcuffs. The female driver was subsequently identified as Nerilla Laurent. At the same time, The male passenger, subsequently identified as Harry Hardy, exited the vehicle and attempted to approach. Officer Fowler
