On 08/01/23, this department was contacted by the Anti-Defamation League (ADL) regarding a social media threat they were currently monitoring. The notification was received by Carol Patrick, the Assistant Director of Incident Response, who I contacted for further information. Upon making telephone contact with Patrick, she provided the contact information for Christopher Delia and Dillon Scott, an Investigative Analyst for ADL. D. Scott was the one who found the social media threat and relayed the information to his boss, C. Delia.

I made telephone contact with both Delia and Scott, who notified me that Scott observed a threatening reply to the Twitter account belonging to ADL's Chief Executive Officer (CEO), [REDACTED], account handle "@J[REDACTED]DL". Upon locating the threatening reply, Scott notified Delia. Upon doing an internal review of the subject, ADL provided information they believed the responsible party to be Brendan Palmaccio, Twitter handle "@Bdubz4444". Scott provided a Twitter link to the threatening post which, upon being clicked, revealed the following Twitter communications:

On 07/29/23, the Twitter handle of [REDACTED] @J[REDACTED]DL, posted to Twitter "Absolutely sickening that antisemite Kanye West was unsuspended from Twitter/X and given a gold verification check mark. He's done absolutely nothing to make amends."

On 07/30/23 at 1453 hours, the Twitter handle that is controlled by Palmaccio, @Bdubz4444, posted in reply to [REDACTED]'s post "You should go fuck your self you nazi fuck never forget 9/11 and fuck your deception ... I wish you would pussy you you supremacists killed my family I'll fucking murder you".

A sworn statement from Dillon Scott was obtained by Det. Leyva.

Upon looking at the handle, numerous posts were made by @Bdubz4444 regarding the

September 11, 2001 terrorist attacks which he stated killed his uncle, Jewish extremism, "false flag" events, and being a truth-seeker.

On 08/02/23, utilizing investigative means, it was learned Palmaccio to possibly reside at 10142 S. 45th Trail, Boynton Beach. Det. Leyva and I proceeded to that address and made in-person contact with Palmaccio's aunt, Susan McGrane. McGrane stated Palmaccio did not reside at that address, and she believed him to reside with his friend, whom she identified solely as "Cole". I informed McGrane that we were investigating concerning statements allegedly made by Palmaccio on social media, which she replied their family is unhappy and do not agree with Palmaccio's posts to social media platforms. McGrane added in the past, she knows Palmaccio's mother to have turned off his cell phone due to his incessant social media posts. McGrane was unable to provide further information regarding the address Palmaccio is residing.

On 08/02/23, I received a telephone call on my department issued cell phone from the phone number [REDACTED] returned the phone call and spoke with an individual who identified himself as Brendan Palmaccio, stating he was made aware that we attempted to contact him by going to his aunt's residence. I informed Palmaccio that contact was attempted due to the nature of some social media posts, and further requested he come to the Boca Raton Police Department, which he agreed to do on 08/02/23 at 1730 hours. It should be noted that following our discussion over the phone, Palmaccio made his Twitter account private, rendering it inaccessible to law enforcement.

On 08/02/23 at approximately 1730 hours, Palmaccio willingly came to Boca Raton Police Department to speak with me regarding this investigation. Upon his arrival, Palmaccio was read his Constitutional Warnings from a pre-printed department-issued card. I spoke with Palmaccio regarding his social media account. Palmaccio stated he lost his uncle on September 11, 2001 and did not feel the media was telling the full story regarding the attacks. He noted that Muslims were good people and while he was not anti-Jewish, he was not in support of the ADL. I provided a printed copy of the above referenced post to Palmaccio, which included both the victim's Twitter handle as well as Palmaccio's Twitter handle. Palmaccio provided a full confession to posting the above referenced threat, further adding he deleted the post today after he realized it was not a good idea. Palmaccio additionally stated that while he did delete the threatening post, he did not delete his Twitter account.

Due to the full confession to operating the Twitter account "Bdubz4444" and posting the threat to include "I'll fucking murder you", probable cause exists to arrest Brendan Palmaccio for violation of 836.10 Written Threats to Kill.
