Your Affiant asked Lowe if he had fallen or cut himself recently and Lowe replied "other than shaving no." Your Affiant showed Lowe a picture of two of the suitcases that Barbosa was found in and asked Lowe if he had ever seen either suitcase. Lowe replied, "No Sir." Your Affiant asked Lowe why there would be a sticker on the suitcase related to his wife's name and he replied, "I don't know."

On 07/31/23 your Affiant authored a search warrant for 315 Venetian Dr. Apt 4. The warrant was granted by the Honorable Judge James Martz. The warrant was executed on the same day. Upon execution of the warrant Detectives observed blood spatter throughout the residence to include the living room, dining room, hallway, both bathrooms and the master bedroom. Blood was detected in the master bath shower drain as well as the tub of the second bathroom. Drag marks were observed in the living room, hallway, and master bathroom. Large amounts of blood were found in the living room, dining room and master bathroom. Numerous cleaning supplies were found throughout the residence some containing blood spatter.

While executing the search warrant Lowe returned to the residence and attempted to enter the residence through the rear window. Lowe was met by Officers and prevented from entering. Lowe stated that he was just trying to get his phone and the keys to his storage unit. Upon search of the spare bedroom detectives located a business card on for Security Storage of Delray located at 2900 Georgia St. in the City of Delray Beach. This desk is the same desk that Lowe requested your Affiant to locate his wallet and retrieve Lowe's credit card and driver's license. A 9mm firearm was located in the drawer of the same desk.

On 07/31/2023 Detective Caceres met with Allison Lazarus at 315 Venetian Dr. Apt 1. Lazarus stated that she has been living in that apartment for over two years. Lazarus advised she knows her neighbors across the way in apartment 4 as Bill and his wife which she did not know how to pronounce her name and stated "Azul". Lazarus stated that earlier today at approximately 0800 hours, while she was walking her dogs, she observed Lowe putting a plastic container tote box into his tan vehicle. Lazarus stated that she last saw Barbosa a couple of weeks ago. Lazarus stated that her dogs would bark when they hear movement and recently, they have been barking between 0130-0330 hours in the morning and she would wake up from her sleep and hear Lowe's apartment door open and close which is unusual to her. Lazarus stated that Lowe sometimes leaves flowers in front of her door and most recently, last Wednesday 07/26/23, she saw flowers on her doorstep in the morning when she went to walk the dogs. Lazarus confirmed with Lowe via text message that he had left her flowers. Lazarus advised that the apartment above Lowe's is owned by Lowe's sister, but she has never seen her since Lazarus has lived
