NARRATIVE:

On Monday, April 28th 2025, at approximately 0800 hours, I drove to the Child Protection Team (CPT) located at 5305 Greenwood Avenue, West Palm Beach, Florida 33407, in reference to prescheduled forensic interviews for [REDACTED] are seven-year-old [REDACTED] with a date of birth of [REDACTED] Both were six-yers-old when this unlawful reported sexual activity took place.

Prior to the Forensic interviews, a CPT Case Coordinator, Advocate, and I attended an informational meeting with [REDACTED] a white female with a date of birth of [REDACTED] [REDACTED] also provided a sworn statement, which included the aforementioned information at a separate time. The following is a brief paraphrased synopsis of the information learned during the interviews:

[REDACTED] explained that she first became aware of the situation on the last Friday of spring break for Palm Beach County, March 28th 2025. While at work, she received a text from [REDACTED] at 11:21 AM who was at home with [REDACTED] reported that [REDACTED] mentioned touching [REDACTED] penis, whom [REDACTED] The text message thread authored by both [REDACTED] [REDACTED] was subsequently uploaded to the Palm Beach County Sheriff's Evidence.com for evidential purposes.

[REDACTED] described [REDACTED] was unable to gauge the seriousness of the situation through text messages. Thus, she waited until she got home to address this with [REDACTED]

Upon coming home from work that evening, she addressed the allegations with [REDACTED] individually. As she spoke with them separately, [REDACTED] both disclosed and confirmed their curiosity, which led them to ask [REDACTED] if they could touch his penis, which he obliged to both of them, permitting each of them to fondle him in his bedroom. Additionally, Norman Rierner permitted [REDACTED] to touch his penis on three more reported incidents, all of which took place at his home while [REDACTED] were reportedly getting a "mani-pedi" (manicure and pedicure).

[REDACTED] also advised on Sunday evening, The Department of Children and Families (DCF) Protective Investigator (PI) and a Deputy Sheriff visited [REDACTED] home to interview the children. The fact finding interviews were conducted in a child-friendly environment to minimize stress. As a result, DCF PI G. Dawson scheduled the Forensic interviews.

NARRATIVE CONTINUATION

For the complete and accurate details of the informational and sworn interview with [REDACTED] authorized person(s) should review the body worn camera recorded interviews.

[REDACTED] was the first to be forensically interviewed by Senior Case Coordinator (CC) Katharine Meuhlberg. The Forensic interview took place in interview room # 2 within the CPT Office.

After CC Meuhlberg established a rapport with seven year old [REDACTED] she confirmed [REDACTED] understood the difference between a truth and a lie resulting in [REDACTED] agreement to tell the truth.

The following is a brief paraphrased synopsis of [REDACTED] disclosure regarding what occurred approximately one year ago when [REDACTED] permitted her to touch his penis. [REDACTED] continued explaining she and [REDACTED] were at Norman Riemer's home. He was watching them while [REDACTED] were getting their nails done.

[REDACTED] described she and [REDACTED] entered [REDACTED] bedroom and asked to touch his penis which she described as his "private area." Norman Riemer permitted both [REDACTED] to touch his penis with their hands. [REDACTED] described putting her hands together and moving them in a back and forth/up and down motion, while mimicking that motion for the recording equipment installed in the interview room.

As the interview progressed, [REDACTED] also disclosed she conducted the same described masturbatory sexual behavior with Norman Riemer three additional times. On one occasion she described when she moved her hands over Norman Riemer's penis in an up and down motion a "drop of water" came out of his penis, followed by stating it was "raining" inferring ejaculation.

Before concluding the Forensic interview, [REDACTED] also disclosed lying on Norman's bed without pants and underwear, next to him. She described Norman touching her inner thigh with his hand and moving his hands in a rubbing motion. [REDACTED] denied that Norman Riemer penetrated her, although she described he touched her around or next to her vaginal area. [REDACTED] pointed towards her crotch area and mimicked the motion of his hands which was recorded.

For the complete and accurate details of the Forensic interview with [REDACTED] authorized person(s) should review the DVD recorded interviews.

After [REDACTED] interview concluded, [REDACTED] was the second and final child victim to be forensically interviewed by Senior Case Coordinator (CC) Katharine Meuhlberg.

After CC Meuhlberg established a rapport with eight-year-old [REDACTED] she confirmed [REDACTED] understood the difference between a truth and a lie resulting in [REDACTED] agreement to tell the truth today.

The following is a brief paraphrased synopsis of what [REDACTED] stated occurred approximately one year ago when [REDACTED] permitted her to touch his penis. [REDACTED] explained she and [REDACTED] were at Norman's home when they entered his bedroom. She and [REDACTED] curiously asked to touch [REDACTED] penis, which he permitted.

Subsequently [REDACTED] disclosed she and [REDACTED] touched Norman's penis while he was seated on his bed. During the interview, [REDACTED] confirmed this occurred one time in her presence in addition to describing Norman Riemer removing his clothing, exposing his penis to facilitate her curiosity of wanting to touch it. Before concluding the interview, [REDACTED] explained that she decided to tell [REDACTED] about the incident after remembering it.

For the complete and accurate details of the Forensic interview with [REDACTED] authorized person(s) should review the DVD recorded interviews. During each individual interview, both [REDACTED] created renditions of Norman Riemer's penis. Those drawings were submitted to PBSO Evidence.

NARRATIVE CONTINUATION

Following the initial disclosures from both [REDACTED] to [REDACTED] meeting was set to take place at [REDACTED] house without [REDACTED] present.

[REDACTED] Norman Rierner drove to [REDACTED] home and all were seated at the dining room table when the discussion started Saturday evening, March 29th 2025. Consequently, [REDACTED] informed [REDACTED] about the allegations. [REDACTED] Norman Rierner admitted and confessed to all who were present: [REDACTED] Norman confessed to the inappropriate conduct, claiming it happened three times and described the unlawful sexual activity as a "science experiment" to satisfy the children's curiosity.

[REDACTED] expressed her anger and disbelief, emphasizing the betrayal of trust. [REDACTED] expressed his intense anger towards Norman during a sworn recorded body worn camera interview. [REDACTED] cared for [REDACTED] enabling [REDACTED] to express her feelings towards [REDACTED] regarding Norman's confession.

At first, [REDACTED] Norman expressed their desire to keep this [REDACTED] before [REDACTED] informed [REDACTED] she had a duty to report this. [REDACTED] subsequently reported the unlawful sexual activity of [REDACTED] to the Department of Children and Families Hot Line the following day, prompting this investigation.

During the course of this investigation probable cause was established to charge Norman Rierner who on five reported incidents did intentionally touch the breasts, genitals, genital area, or buttocks, or the clothing covering them of [REDACTED] a person less than 12 years of age, in a lewd and lascivious manner {or} did force or entice both [REDACTED] to so touch Norman Rierner, in that Norman Rierner did permit and facilitate their ability to inappropriately touch his penis in a masturbatory manner and Norman Rierner, was 18 years of age or older, pursuant to Florida Statute 800.04(5)(a) and (b). (A life felony for each count)
