You have been charged by Information for the below listed offenses, by the State of Florida:

Clerk of the Circuit Court & Comptroller
Palm Beach County, FL

- (1) FRAUDULENT USE OF CREDIT CARD>\$100
- (2) FRAUDULENT USE OF PERSONAL IDENTIFICATION INFORMATION

Having been advised of your Constitutional Rights, and it further appearing that after an investigation of the offense and into your background, the interest of the State of Florida, and your interest, will best be served by entering into this Pretrial Intervention Agreement.

Therefore, ALEXCIA COX, State Attorney, in and for the Fifteenth Judicial Circuit, Palm Beach County, Florida, agrees that prosecution in this matter for said offense will be deferred for a period of 12 MONTHS from this date, provided you abide by the following conditions:

1. You will refrain from violation of any law.
2. You will pay to the State of Florida Fifty (\$50.00) Dollars per month towards cost of your supervision unless exempted in compliance with Florida Statutes.
3. You will pay Two Hundred (\$200) Dollars for the Cost of Prosecution.
4. You will work regularly at a lawful occupation and support any dependents to the best of your ability.
5. You will not change your residence or employment or leave the State of Florida without first procuring the consent of your Pretrial Intervention (PTI) Officer.
6. You will make yourself available for the services of the Pretrial Program by reporting in person to your PTI Officer as directed.
7. You acknowledge that your employer must be informed of your status in the program within thirty (30) days of your acceptance or within thirty (30) days of employment, should you obtain a new position after acceptance.
8. You will neither possess nor carry any firearm or weapon.
9. You will truthfully answer all inquiries by your Pretrial Intervention Officer and agree that the officer may visit your home, employment, school or elsewhere without your prior approval and comply with all instructions he or she may give you.
10. You will not use intoxicants to excess, nor will you visit places where intoxicants, drugs or other dangerous substances are unlawfully sold, dispensed or used.
11. You will submit to a urinalysis, breathalyzer, or blood tests at any time requested by your Pretrial Intervention Officer. Should you test positive for a controlled substance, you may be required to receive a Drug Evaluation and treatment, if recommended.
12. If you violate any of the conditions of this Pretrial Intervention Agreement, then this agreement will be terminated and the case will be returned to court to resume the prosecution. This Pretrial Intervention Agreement will also be terminated if it is determined you have any prior adult felony convictions (includes any withhold of adjudication).
