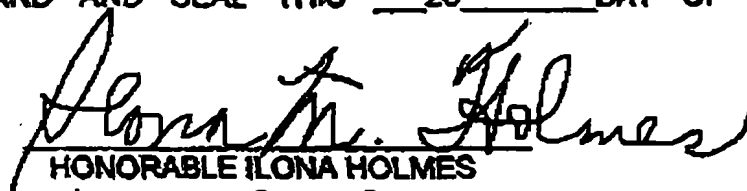

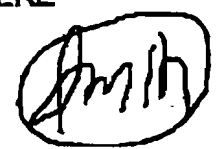

BEFORE THE UNDERSIGNED ILONA HOLMES, JUDGE OF THE CIRCUIT COURT OF THE SEVENTEENTH JUDICIAL CIRCUIT IN AND FOR BROWARD COUNTY, FLORIDA COMES DETECTIVE RYAN RILLO OF THE HOLLYWOOD POLICE DEPARTMENT, WHO HAS PRESENTED, VIA ELECTRONIC MEANS PURSUANT TO FS 933.07 THIS GENERAL AFFIDAVIT AND APPLICATION FOR ARREST WARRANT REGARDING CASE NUMBER 33-1405-066179, WHO HAS BEEN DULY SWORN AND SAYS:

DETECTIVE RILLO OF THE HOLLYWOOD POLICE DEPARTMENT, WHO FIRST BEING DULY SWORN, DEPOSES AND SAYS THAT HE HAS PROBABLE CAUSE TO BELIEVE, AND DOES BELIEVE THAT ON OR ABOUT THE 18TH DAY OF MAY, 2014, IN THE CITY, COUNTY AND STATE AFORESAID, PATRICIA ANN BRENNAN DID THEN AND THERE

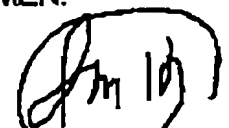


UNLAWFULLY COMMIT THE ACT OF FELONY MURDER OF A HUMAN BEING, REGINA SUKNAIC, A WHITE FEMALE WHOSE DATE OF BIRTH IS 11/29/1937, BY STABBING THE VICTIM TWO TIMES AND HOLDING HER CAPTIVE FOR THIRTEEN HOURS RESULTING IN HER DEATH, CONTRARY TO F.S.S 782.04-2F FELONY MURDER.

THAT THE FOLLOWING GROUNDS CONSTITUTE AFFIANT'S REASON FOR HIS BELIEF THAT THE LAWS OF THE STATE OF FLORIDA WERE VIOLATED AS STATED ABOVE AND THE FACTS ESTABLISHING THE GROUNDS FOR THIS AFFIDAVIT AND THE PROBABLE CAUSE FOR BELIEVING THAT SUCH FACTS EXIST ARE AS FOLLOWS:

ON 05-18-14 AT APPROXIMATELY 12:14PM OFFICER'S WERE DISPATCHED TO 1810 NORTH 38TH AVENUE IN REFERENCE TO A DELAYED STABBING. DISPATCH ADVISED RESPONDING OFFICER'S THAT THE VICTIM WAS AT A NEIGHBORS HOUSE LOCATED AT 1810 NORTH 38 AVENUE. THE NEIGHBOR WAS IDENTIFIED AS STEVEN FENNEL. VICTIM SUKNAIC STATED TO WITNESS FENNEL THAT HER DAUGHTER, THE ARRESTEE, HAD STABBED HER THE NIGHT BEFORE.

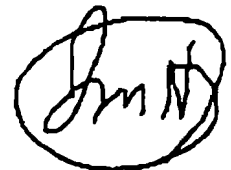
UPON OFFICER POLO'S ARRIVAL, CONTACT WAS MADE WITH THE RESIDENT OF 1810 N 38TH AVENUE, STEVEN FENNELL, AND THE VICTIM. OFFICER POLO #3358 OBSERVED THE VICTIM SITTING ON A LAWN CHAIR OUTSIDE OF THE RESIDENCE IN A NIGHT GOWN, STAINED WITH WHAT APPEARED TO BE BLOOD IN DIFFERENT STAGES OF COAGULATION. THE BLOOD APPEARED TO BE COMING FROM THE VICTIM'S MIDSECTION. THE VICTIM HAD MULTIPLE PUNCTURE WOUNDS ON HER ABDOMEN.



WITNESS FENNELL STATED TO OFFICER POLO THAT THE VICTIM STUMBLED OVER TO HIS HOUSE, TOLD HIM SHE HAD BEEN STABBED BY THE ARRESTEE, THAT SHE WAS BEING HELD AGAINST HER WILL; SHE JUST ESCAPED AND NEEDED TO CALL 911.

OFFICER POLO STATED THAT THE VICTIM APPEARED PALE, LACKED ENERGY, AND HAD MULTIPLE BRUISES ON HER FACE. SHE HAD TO BE HELPED ON TO THE STRETCHER AND TRANSPORTED TO MEMORIAL REGIONAL HOSPITAL. WHILE EN ROUTE TO THE HOSPITAL THE VICTIM TOLD THE PARAMEDICS ON RESCUE 74 THAT THE PREVIOUS NIGHT, 05-17-14, AT APPROXIMATELY 2300 HOURS, THE ARRESTEE STABBED HER IN THE ABDOMEN WITH A BUTCHER KNIFE AND STRUCK HER ON THE BACK OF HER HEAD WITH A BOTTLE. SHE STATED THAT SHE WAS THEN HELD AGAINST HER WILL UNTIL 05-18-14 AT APPROXIMATELY 1214 HOURS WHEN HER DAUGHTER FELL ASLEEP AND SHE WAS ABLE TO ESCAPE TO HER NEIGHBORS HOUSE TO CALL FOR POLICE.

OFFICER POLO MADE CONTACT WITH THE ARRESTEE WHO STATED THAT SHE DID NOT KNOW WHAT OCCURRED WITH HER MOTHER BECAUSE SHE WAS ASLEEP. SHE STATED THAT A FEW DAYS AGO TWO MALES BROKE HER DOOR DOWN, PUSHED HER INTO A WALL AND TOOK HER MONEY. SHE STATED THAT SHE DID NOT CALL THE POLICE. THERE WAS NO EVIDENCE THAT WOULD CORROBORATE THE STORY TOLD BY THE ARRESTEE. THE ARRESTEE STATED SHE DID NOT KNOW HOW HER MOTHER WAS STABBED BECAUSE SHE WENT TO SLEEP AT MIDNIGHT.



BASED ON THE WITNESS STATEMENTS OFFICER POLO AFFECTED THE ARREST OF PATRICIA ANN BRENNAN. DETECTIVE ADAMS #2672 RESPONDED TO THE SCENE. DETECTIVE ADAMS PREPARED A SEARCH WARRANT FOR THE RESIDENCE WHICH WAS SIGNED BY THE HONORABLE TOWBIN SINGER.

THE ORIGINAL SEARCH WARRANT WAS EXECUTED BY DETECTIVE ADAMS #2672 ON 05/18/14, WITH CRIME SCENE TECH BARCOMB #3343. A SEARCH OF THE RESIDENCE REVEALED A BLOOD SCENE IN THE CENTER BEDROOM. THE SCENE CONSISTED OF BLOOD SPLATTER ON THE NORTH WALL, COMFORTER, SHEET AND PILLOW CASE. THE BLOOD SCENE WAS MOSTLY CONTAINED IN THE CENTER BEDROOM.

THE EXTERIOR POINTS OF INGRESS AND EGRESS WERE INTACT AND DID NOT HAVE ANY SIGNS OF TAMPERING OR FORCED ENTRY.

ON 05/21/14, THE HOMICIDE UNIT WAS NOTIFIED THAT THE VICTIM'S CONDITION HAD DETERIORATED AND HER CHANCE OF SURVIVAL WAS SLIM DUE TO VICTIM'S ADVANCED AGE AND INJURIES. THIS DETECTIVE AUTHORED, AN SEARCH SEARCH WARRANT TO RE-ENTER THE PREMISES FOR ADDITIONAL PROCESSING. THE SEARCH WARRANT WAS SIGNED BY THE HONORABLE TOWBIN SINGER.

THE SECOND SEARCH WARRANT WAS EXECUTED AT 1600 HOURS AT THE VICTIM'S RESIDENCE LOCATED AT 1920 NORTH 38 AVENUE. CRIME SCENE TECHNICIANS BARCOMB #3343 AND VIGNAU #3340 PROCESSED THE SCENE.



A LOUNGE CHAIR WITH ARMRESTS WAS LOCATED WITH IN THE FAMILY ROOM. THIS DETECTIVE OBSERVED THE HANDLE OF A KNIFE THAT WAS WEDGED BETWEEN THE SEAT CUSHION AND RIGHT ARM REST. THE HANDLE WAS FACING THE FRONT OF THE CHAIR AND THE BLADE WAS FACING THE REAR OF THE CHAIR. THE KNIFE WAS PHOTOGRAPHED AND ULTIMATELY COLLECTED BY THE CRIME SCENE TECHNICIANS. THE BLADE OF THE APPROXIMATE 5.5 INCH LONGHORN SERRATED STEAK KNIFE APPEARED TO HAVE DRIED BLOOD ON THE BLADE AND SERRATIONS.

A BLOOD SCENE WAS LOCATED IN THE CENTER BEDROOM OF THE RESIDENCE. HIS BEDROOM APPEARED TO BE THE LOCATION WHERE THE STABBING OCCURRED. THE MATTRESS, COMFORTER AND BED SHEET APPEARED TO BE STAINED WITH DRIED BLOOD. A SHARP FORCE INCISION WAS LOCATED IN A PILLOW ENCLOSED IN A PILLOW CASE. THE INCISION DID NOT PENETRATE BOTH SIDES OF THE PILLOW CASE. AN ADDITIONAL SHARP FORCE INCISION APPROXIMATELY SIX INCHES DEEP WAS DISCOVERED IN THE APPROXIMATE ELEVEN INCH THICK MATTRESS. THE INCISION PENETRATED INTO THE SPRING CAVITY OF THE MATTRESS.

THE NORTH WALL OF THE CENTER BEDROOM CONSISTED OF A DOUBLE WINDOW. THE WESTSIDE OF THE WINDOW WAS COVERED WITH A RED CURTAIN. THE EAST SIDE OF THE WINDOW WAS UNCOVERED. BLOOD SPATTER AND CAST OFF WAS OBSERVED AND DOCUMENTED ON THE WALL, UNCOVERED WINDOW AND CEILING.



AN EMPTY 750 MILLILITER GLASS BOTTLE OF BOMBORA VODKA WAS DISCOVERED ON THE FLOOR OF THE BEDROOM. DRIED BLOOD APPEARED TO BE PRESENT ON THE VODKA BOTTLE EVIDENCE INDICATED THAT THE STABBING TOOK PLACE IN THIS BEDROOM.

DETECTIVE ADAMS AND I MADE CONTACT WITH THE REPORTER IDENTIFIED AS WITNESS STEVEN FENNEL WHO PROVIDED A SWORN DIGITALLY RECORDED STATEMENT AT HIS RESIDENCE. WITNESS FENNEL STATED THAT HE HEARD A NOISE FROM THE FRONT DOOR OF HIS RESIDENCE WHEN THE DOOR PARTIALLY OPENED. HE THEN MADE CONTACT WITH THE VICTIM AT THE OPEN DOORWAY WHO WAS HUNCHED OVER IN PAIN AND ASKING FOR ASSISTANCE. THE WITNESS OBSERVED DRIED BLOOD ON THE VICTIM'S WHOLE MIDSECTION, A BLACK EYE AND CUTS TO HER FACE. THE VICTIM STATED THAT PATTI (DAUGHTER) STABBED HER A FEW TIMES. IT OCCURRED AT NIGHT, THAT SHE WAS HIT AND THAT PATTI IS IN THE HOUSE ASLEEP.

DETECTIVE ADAMS AND I MADE CONTACT WITH HOLLYWOOD FIRE DEPARTMENT LIEUTENANT DIANA DEABREU WHO RESPONDED WITH RESCUE 74 TO THE SCENE TO RENDER MEDICAL AID. WITNESS DEABREU PROVIDED A SWORN DIGITALLY RECORDED STATEMENT AT 2741 STIRLING ROAD.

WITNESS DEABREU STATED THAT UPON HER ARRIVAL, SHE OBSERVED DRIED BLOOD ON THE VICTIM'S GOWN, BLACK EYES AND MULTIPLE BRUISES TO HER BODY. THE VICTIM STATED TO THE WITNESS THAT

SHE WAS STABBED WITH A BUTCHER KNIFE AT 2300 HOURS ON 05/17/14, BEAT ALL NIGHT LONG IN HER BED, HIT IN THE HEAD WITH A BOTTLE AND HELD AGAINST HER WILL. HER DAUGHTER FELL ASLEEP AND SHE WAS ABLE TO CRAWL OUT OF THE HOUSE AND WALK TO A NEIGHBORS HOUSE. THE DAUGHTER IS FIFTY ONE YEARS OLD.

DETECTIVE ADAMS AND I MADE CONTACT WITH HOLLYWOOD PARAMEDIC RIDARD TOUSSAINT WHO WAS A CREW MEMBER OF RESCUE 74. A SWORN DIGITALLY RECORDED STATEMENT WAS TAKEN FROM THE WITNESS AT 2741 STIRLING ROAD.

WITNESS TOUSSAINT OBSERVED BRUISING AROUND THE VICTIM'S FACE AND ON HER BODY. THE VICTIM STATED THAT THE INCIDENT STARTED AT 2300 HOURS ON 05/17/14, SHE WAS STABBED, BEATEN HELD AGAINST HER WILL AND THAT HER DAUGHTER IS FIFTY ONE YEARS OLD. THE VICTIM WAITED FOR HER DAUGHTER TO FALL ASLEEP. SHE THEN CRAWLED OUT OF THE RESIDENCE AND WENT TO THE NEIGHBORS HOUSE.

A NEIGHBORHOOD CANVASS WAS CONDUCTED AND POTENTIAL WITNESSES WERE IDENTIFIED.

05/28/14

A SWORN DIGITALLY RECORDED STATEMENT WAS TAKEN FROM WITNESS DAVID COLLINS AT 1928 NORTH 38 AVENUE, ONE HOUSE NORTH OF THE VICTIM'S. THE WITNESS STATED THAT HE PARKED HIS



VEHICLE IN HIS REAR DRIVE WAY AT 2045 HOURS. HE EXITED HIS VEHICLE AND HEARD YELLING COMING FROM THE VICTIM'S RESIDENCE. HE HAS KNOWN THE ARRESTEE SINCE HE WAS A CHILD AS SHE USED TO BE HIS SITTER. HE READILY RECOGNIZED THE ARRESTEE'S VOICE. HE ENTERED HIS RESIDENCE AND CAN STILL HEAR THE ARRESTEE YELLING. HE OPENED HIS LIVING ROOM WINDOW WHICH IS LOCATED ON THE SOUTHEAST PORTION OF HIS RESIDENCE. HE COULD HEAR THE ARRESTEE YELLING ABOUT THE LOSS OF HER FATHER, CALLING THE VICTIM VULGAR NAMES, TELLING THE VICTIM SHE IS A HORRIBLE MOTHER, TELLING THE MOTHER THAT SHE HATES HER, BLAMING THE VICTIM FOR NOT BEING THERE WHEN HER FATHER DIED, AND SHE MISSED HER FATHER. THE ARRESTEE WOULD THEN SOB AND BEGIN YELLING IN A GROWLING VOICE THAT 'I FORGIVE YOU BUT IF YOU EVER...' THE VICTIM DID NOT HEAR THE LAST WORDS BUT UNDERSTOOD THE COMMENT AS A THREAT.

THE VICTIM STATED THAT THE ARGUING STOPPED AT 2300 HOURS ON 05/17/14. THE WITNESS ONLY HEARD ON FEMALE VOICE COMING FROM THE RESIDENCE THAT HE IDENTIFIED AS THE ARRESTEE.

WITNESS COLLINS ADVISED THAT THE YELLING WAS COMING FROM THE ROOM LOCATED THREE WINDOWS TO THE WEST FROM THE EAST SIDE OF THE RESIDENCE. THE VICTIM DID POINT THE WINDOW OUT TO ME WHICH IS DOCUMENTED IN THIS REPORT AS THE CENTER BEDROOM WHERE THE BLOOD SCENE WAS DISCOVERED. THE WITNESS WAS CONCERNED ABOUT THE ARGUMENT AND STATED THAT HE

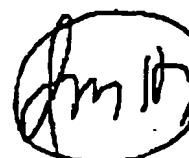
THIS DETECTIVE CHECKED ON THE VICTIM'S CONDITION DAILY. THE VICTIM WAS TRANSFERRED FROM MEMORIAL REGIONAL HOSPITAL INTENSIVE CARE UNIT TO MEMORIAL HOSPITAL SOUTH HOSPICE BY THE SEA ON 05/26/14.

05/27/14

I WAS NOTIFIED THAT THE VICTIM HAD PASSED AWAY. I MADE CONTACT WITH THE VICTIM'S NURSE WHO ADVISED THAT DOCTOR EIMMERMAN PRONOUNCED THE VICTIM AS DECEASED AT 0810 HOURS. THE DECEDENT WAS TRANSPORTED BY BROWARD REMOVAL TO THE BROWARD COUNTY MEDICAL EXAMINER'S OFFICE.

ASSOCIATE MEDICAL EXAMINER DOCTOR DARIN TRELKA OF THE BROWARD MEDICAL EXAMINER'S OFFICE PERFORMED AN AUTOPSY OF THE VICTIM AT APPROXIMATELY 1050 HOURS.

THE DECEDENT HAD TWO CONTUSIONS ON HER FOREHEAD THAT DID NOT RESULT IN HEAD FRACTURES. MULTIPLE SHARP SUPERFICIAL CUTS WERE OBSERVED ON HER BODY. TWO STAB WOUNDS WERE OBSERVED ON LEFT SIDE OF HER ABDOMEN. THE STAB WOUND CLOSEST TO HER HEAD WAS SEVEN EIGHTHS OF AN INCH LONG. THE LOWER STAB WOUND CLOSEST TO HER FEET WAS ONE INCH LONG. SEE DOCTOR TRELKA REPORT FOR COMPLETE DETAILS.

DOCTOR TRELKA DETERMINED THE MANNER OF DEATH TO BE A
HOMICIDE, MULTIPLE STAB WOUNDS TO THE TRUNK AREA.

THE SEVENTY SIX YEAR OLD ELDERLY VICTIM WAS HELD AGAINST HER
WILL WITH OUT LAWFUL AUTHORITY FOR THIRTEEN HOURS WHILE SHE
WAS VIOLENTLY VICTIMIZED AND TERRORIZED BY BEING STABBED
TWICE, STRUCK IN THE HEAD WITH A GLASS BOTTLE AND BEATEN ALL
NIGHT IN HER BED. THE VICTIM ESCAPED TO SEEK MEDICAL AIDE FROM
HER ABDUCTOR WHEN SHE FELL ASLEEP. THE VICTIM DIED AS A
RESULT OF HER INJURIES ON 05/27/14 AT 0610 HOURS.

THIS OFFENSE(S) SET FORTH IN THE FOREGOING AFFIDAVIT ARE
